

# **Revised annotated programme of work for the informal meeting of experts on lethal autonomous weapons systems Geneva, 13 – 17 April 2015**

**Submitted by the Chairperson of the informal meeting of experts**

## **Monday 13 April**

**10:00 a.m. – 1:00 p.m.**

### **General debate**

1. The general exchange of views will build on the debate of the first informal Meeting of Experts in May 2014 and highlight questions from last year's discussions on technical issues, ethical and sociological issues, international humanitarian law, other areas of international law and operational and military aspects.
2. This could also be an opportunity to share positions on national policies, national legal provisions and expectations regarding the international debate on LAWS.

### **Technical issues**

3. In order to enhance the understanding of current developments, this session will address the state of play in the development of increasingly autonomous functions in technical systems, increasing complexity and autonomy in weapon systems as well as in civilian autonomous systems. The issues of resilience against programming and deployment errors and the vulnerability of LAWS to cyber-attacks merit closer attention. In addition, an exchange on the military rationale for increasing autonomy in weapons systems may provide for a better understanding of the subject under discussion.
4. The possible topics for discussion are:
  - (a) State of play in the development of:
    - Increasingly autonomous functions in technical systems in general;
    - Increasing complexity and autonomy in weapon systems;
    - Current research and expected further developments.
  - (b) Military rationale for autonomous functions in weapons systems.
  - (c) Furthermore the following issues will be addressed:
    - Resilience against programming errors;
    - Resilience against deployment errors;
    - Vulnerability to cyber attacks.

### **Characteristics of lethal autonomous weapons (LAWS)**

5. During the first informal Meeting of Experts on LAWS, the need for a clearer understanding of defining elements on LAWS was frequently raised. This session will discuss elements for an understanding on LAWS. This could include issues such as the concept of meaningful human control, responsibility, predictability, the issues of autonomy with reference to context and tasks, and the critical functions of LAWS. In this context, it could be useful to draw on the experiences of autonomous technologies in the civilian sector, while at the same time differentiating them clearly from LAWS. This discussion could include the issue of legal responsibility with reference to delegation of authority and decision-making (e.g. risks of accidents in the use of autonomous vehicles and robots, etc.). In addition, it would be pertinent to draw possible lessons from the way other regimes deal with dual use technology (e.g. chemicals, missile technology).

6. The possible topics for discussion are:

(a) Elements for an understanding of defining characteristics, including:

- Meaningful human control;
- Autonomy with reference to context and tasks;
- Critical functions essential to and specific of LAWS.

(b) Dual use characteristics of technology:

- Technology elements used in the civilian sphere as well as by LAWS;
- Drawing from experiences in the civilian sphere:
  - Decision making;
  - Legal responsibility for actions of autonomous systems;
  - Regulations regarding civilian autonomous technology.

(c) Drawing from experiences with other regimes dealing with dual use technology (e.g. chemicals, missile technology).

### **Possible challenges to international humanitarian law (IHL) due to increasing degrees of autonomy**

7. Several issues have been raised during the discussions in the 2014 informal Meeting of Experts and during preparatory consultations regarding possible risks to the unconditional respect of international humanitarian law in the deployment of LAWS. By their very nature LAWS pose particular challenges with regard to an uninterrupted accountability chain, distinction, proportionality and precautions in attack. Based on the discussions in 2014, this meeting will contribute to deepening the understanding of these issues. Two further issues are the link between degrees of autonomy and deployment rules (e.g. standard operating procedures) and the implementation of legal weapons reviews according to Article 36 of the Protocol additional to the Geneva Conventions of 12 August 1949, and relating to the protection of victims of international armed conflicts (Additional Protocol I).

8. The possible topics for discussion are:

(a) The targeting rules:

- Accountability chain;
- Distinction;
- Proportionality;
- Precautions in attack.

(b) Link between degrees of autonomy and deployment rules (e.g. standard operating procedures).

(c) Implementation of legal weapons reviews (Article 36 of Additional Protocol I).

## **Thursday 16 April**

### **Overarching issues**

9. This session will give room to a more-in-depth discussion of human rights, ethical issues and issues of social acceptability as they relate to LAWS. In particular the basic tenets of the right to life, dignified death and the protection of human persons by the principles of humanity and the dictates of the public conscience (Martens Clause). There will also be an exploratory discussion of general security issues. This could include the strategic implications of LAWS, their impact on strategic and regional stability, their relevance for asymmetric contexts and the risks of proliferation.

10. The possible topics for discussion are:

- (a) Human rights and ethical issues;

- (b) General security issues.

**Way ahead**

11. This is an opportunity for the CCW High Contracting Parties to outline areas of common ground and a possible framework for the future debate on LAWS, including in the context of the forthcoming CCW Review Conference, the possibility of a group of governmental experts on LAWS in the CCW and further research requirements. In the context of how to deal with LAWS in the future, it would be appropriate to explore the issue of possible areas for building trust and transparency in the development and acquisition of LAWS (e.g. implementation of Article 36 of Additional Protocol I and deployment (e.g. standard operating procedures). Furthermore, a discussion on possible elements for agreements on regulations/restrictions or a code of conduct could ensue.

12. The possible topics for discussion are:

- (a) Possible areas for transparency in:
  - LAWS development and acquisition (e.g. Implementation of Article 36 of Additional Protocol I);
  - Deployment (e.g. standard operating procedures).
- (b) Possible common ground regarding elements for:
  - Code of Conduct;
  - Regulations;
  - Restrictions;
  - Prohibitions.
- (c) Possible framework for the future debate on LAWS.
