Steps taken to implement the provisions of Article 3:

The clearance, removal and destruction of explosive remnants of war (ERW) within the territory of Hungary is the responsibility of the EOD unit of the Hungarian Defence Forces (HDF), according to the 1999 Government Regulation. In 2012, there were 2934 EOD incidents registered at the EOD ment of the HDF, where 45 414 pieces of ERW's were destroyed. The total weight of the destroyed V's is 25 171,1 kg. Most of these ERW's were remnants from World War II. During the EOD ions of the unit, 248,6 hectares of territory were cleared from Unexploded Ordnance (UXO).

Hungary records every available information about the ERW's found in the territory of the country according to the current regulations. This information is available at the EOD Regiment of the HDF and is released to other organizations upon request, in accordance with the current regulations about this information.

Moreover, in the HDF there's a two-fold recording and retaining information in national bases, in homeland as well as in multinational environment:

- operational: each unit engaged in operations has to mention in its reports all use of explosive munitions and, if applicable, all abandoned munitions.
- logistical: all use of munitions is recorded and reported.
