Information to the Armed Forces

As in previous years all ranks soldiers within the Polish Armed Forces have received on routine basis training commensurate with their duties and responsibilities to comply with the provisions of the Amended Protocol II (AP II) to the Convention of Certain Conventional Weapons. Moreover, due attention was dedicated to the Amended Protocol II issues both during three special courses on International Humanitarian Law organised for battalion commanders and in the framework of soldiers training before sending them to the mission in Afghanistan. The Polish Ministry of National Defence published an educational textbook on International Humanitarian Law in Armed Forces.

International co-operation on mine clearance

At the reporting period Poland contributed to the alleviation of the humanitarian problem caused by irresponsible use of landmines in different parts of the world. In particular the Polish Engineering Forces personnel were engaged in various peacekeeping and stabilising missions abroad, executed tasks for the benefit of local populations additionally to their mandatory tasks. The activities included among others removal and destruction of mines, unexploded ordnance (UXO) and other explosive remnants of war (in cases of emergency), as well as providing warning and risk education to the affected communities.

In the reporting period Polish personnel, acting in close co-operation with other participants of the missions, fulfilled in particular following tasks:

- identification and mitigation of threats caused by mines and UXO;
- mines and UXO clearing activities;
- removal of unexploded ordnance and abandoned munitions from affected areas and storage facilities;
- co-ordination of and support to mine-clearance operations conducted by specialised commercial companies and international non-governmental demining organisations;
- mine threat control associated with preliminary adaptation of buildings for personnel needs;
- providing warning and risk education to the affected communities.

In 2006\* 5 sub-units of Polish engineers were designated to the military missions listed below. The total costs borne by Ministry of Defence as a result of deploying of 80 of de-miners, who were directly involved in UXO and mine clearance operations in 2006, has been estimated to be about 950000 €. The amount expenditures indicated above covers vaccinations, training, insurance, salary as well as board and accommodation costs but omits operational costs related to transportation means and other military equipment. At that time the de-miners identified and destroyed the following amounts of dangerous items:

- under auspicious of UN - UNDOF Syria:
  - 13 pcs of anti-personnel and anti-tank mines;
  - 95 pcs of unexploded ordnance;
- under auspicious of EU - EUFOR Bosnia and Herzegovina:
  - 70 pcs of anti-personnel and anti-tank mines;
  - 67 561 pcs of munitions of various types, mainly for SALW;
  - 19,2 kg explosives;

- under auspicious of NATO - KFOR Kosovo:
  - 7 pcs of anti-personnel and anti-tank mines;
  - 134 pcs of unexploded ordnance;
- within the framework of Operation “Enduring Freedom” in Afghanistan:
  - 69 pcs of anti-personnel and anti-tank mines;
  - 2 686 pcs of munitions of various types and unexploded ordnance;
  - moreover area of 16 097 m<sup>2</sup> has been checked and cleared;
- within the framework of Stabilisation Forces in Iraq:
  - 4 pcs of anti-personnel and anti-tank mines;
  - 9 843 pcs of artillery, mortar munitions, hand grenades, anti-tank missiles, air bombs and munitions for SALW and unexploded ordnance;
  - 26 kg explosives.

\* The current reporting procedures concerning dangerous items do not allow to present data corresponding exactly to the reporting period.
